Dear Miguel Santana,

This letter is in reference to contract agreement M85373-7100 for the California Jobs First (CERF) Planning Phase. This letter serves as a notification to the Los Angeles County Region of the formal request to submit a finalized Collaborative Governance Committee by January 31, 2024.

Per the terms of the Solicitation for Proposal for this grant, which is a binding agreement, your region is required to establish a Collaborative Governance Structure, which must illustrate a transparent decision-making process and reflect that no individual member of the governance committee has more decision-making power than the other. The governance committee must include balanced representation, including but not limited to:

- Labor organizations
- Employers, businesses, and business associations
- Grassroots and community-based organizations, community organizers, and community members
- Government agencies
- Economic development agencies
- Philanthropic organizations
- Education and training providers
- Workforce entities
- Environmental justice organizations
- Worker centers
- Disinvested communities
- California Native American Tribes
- Other regional stakeholders capable of contributing to the success of the project.

The Fiscal Agent on behalf of the HRTC is required to submit the following:

- Governance committee roster.
 - Roster must include the First Name, Last Name, Email, Name of Organization, and stakeholder group for each member of the governance committee.



- 2. The governance committee must be operational by January 31, 2024.
 - Region must submit the governance committee meeting agenda and meeting minutes to satisfy the requirement.
- 3. Summary of the governance committee selection process.
 - In no more than 350 words, provide a summary describing the selection process for your region's governance committee.
