Meeting Summary Notes

SCAG Presentation of EPA' Climate Reduction Gran Program

The meeting begins with greetings and overview of the agenda. A meeting moves to cover a presentation by Ryan Wolf from SCAG about the Climate Pollution Reduction Grant Program, which aims to support efforts in complying with the Paris Accords and reducing emissions. Ryan provides background information on the program, its objectives, timeline, and eligibility criteria for applying for grants. He also discusses the different agencies involved in facilitating the effort and highlights the importance of creating a Regional Climate Action Plan as a prerequisite for implementation funding. The transcript ends with an explanation of phase two of the program, which involves applying for implementation grants ranging from 2 million to 500 million dollars. Eligible applicants include states, municipalities, tribes, and territories. Individual applicants can sub-award to other jurisdictions, including counties and cities. Coalitions can also apply together. Programs can be new or expanded, with a focus on GHG reduction and benefiting disadvantaged communities. Various sectors are eligible for funding, including transportation, electric power, industrial, wastewater, sustainable materials, agriculture, and carbon removal projects. The program aims to strengthen regional climate planning and collaboration. CBOs may partner with municipalities or other eligible entities but cannot apply directly. There is uncertainty regarding partnerships between public agencies and nonprofits due to lack of clarity in the NOFO guidance. Specific projects and investments that benefit communities should be included in the PCAP for eligibility purposes.

Steering Committee Introductions:

The meeting proceeded with an opportunity for introductions so that the Steering Committee members could get to know one another. The participants express excitement about working together to create sustainable and equitable opportunities for communities in Los Angeles County.

Election Results: Chair, Vice Chair A and Vice Chair B

The CERF team overviewed the election results and announced Kevin Harbour as the newly elected chair of the Steering Committee. Andrea Slater will be Vice Chair A and Stella Ursua will be Vice Chair B. Results are displayed in the PowerPoint presentation.

Steering Committee Bylaws Update:

An update on the Bylaws was given. The CERF team has received the feedback from the SC members, and they are working on drafting a working document with the request provisions. Feedback from steering committee members was given that working meetings should be scheduled to allow the SC members to work more thoroughly on the Bylaws. The CERF Team committed to working with the Chairs to implement working meetings to help draft and finalize the Bylaws document. A working document will be shared for further review and comments next week.

Fiscal Agent Updates: CCF

Matia provided updates stating that 2/3 research reports have been contracted. Beacon Economics and CVL Economics, Industry Cluster Contract did not receive any bids, CCF is working on a solution. Steering Committee members requested a profile of the 2 research companies that were chosen for the research contracts. CCF is working on contracting with PayKeeper, that will work with them on issuing out the grants to all the Affinity Hub Leads, would like to have that completed in the next couple of weeks.

Maria provided an update that the Catalyst grant application has been shared with Fiscal Agents, as an invite only solicitation. The Convenor, Fiscal Agent and Chairs will be meeting with the grant writer later today to begin looking at that grant application. LAN'Synch was recognized for bringing the support to hire a grant writer to assist in applying for the Catalyst funding. Steering Committee Members requested to see the application; Maria committed to sharing this with the CERF team to include in the meeting highlights newsletter that will be going out to the Steering Committee.

The CERF team will provide an update as a solution is reached.

- 4. **Labor Engagement**: There is a plan to address labor engagement by having a meeting between the steering committee chairs and the state, followed by a meeting between labor and the chairs to discuss their involvement.

And if you're not really familiar with Skag, we're the regional planning agency covering six counties. And today we are here to talk to you about the Climate Pollution Reduction Grant Program, which is an EPA grant program that stemmed from the Inflation Reduction Act. And I can start presentation whenever you are.

I'm going to go through the background of this and what this program is focused on today, as well as who's involved in it, and then we can take some questions. So for all of you, the Inflation Reduction Act is where this program comes from. As you may know, this program is really geared towards supporting the national effort to comply with Paris Accords, reduce emissions significantly, and also create regional and national jobs, as well as reduce air pollution and address environmental justice more broadly. This program, the CPRG, is one of the largest programs in the Inflation Reduction Act and so it has a total of \$5 billion. It's in two phases. The first part is these planning grants which go to states, regions and tribes to create essentially climate action plans. One of the early deliverables is called what's a Priority Climate Action Plan, which is a prerequisite for applying for the second phase of this program, which is this \$4.6 billion in competitive implementation grants.

And I'll get into it a little bit later, but these grants can fund a wide variety of projects across economy wide sectors, everything ranging from transportation to building energy to active transportation to waste. So it's a very wide variety of projects that it can potentially fund. It has three core objectives. The program so reduce climate and air pollution, supporting jobs and lower energy costs, and then addressing environmental justice. And I'll also get back to this, but it's defined here as not what we use in the state broadly, the disadvantaged communities as per SB 535, but instead is filtering this through the justice 40 initiative at the federal level, which overlaps very substantially with our 535 communities. So this is the current timeline. And just noting this program is a

really fast moving program. The EPA announced this earlier this spring and it released the implementation guidelines in September.

So just last week. And then this first delivery I mentioned, the PCAP is due on March 1. And again, this establishes what can be applied for under this program. And in our region we have a PCAP planning grant which covers La County and Orange County. So a variety of agencies are working together to facilitate this regional effort. And then the application grants themselves are due on April 1 of 2024. So at the same time as we're creating this PCAP, we're also looking forward to what kinds of projects can be applied for. So get a little bit more into the phase one planning grants, which is where we are now. And just wanted to give you a little bit background on the different agencies that are helping to facilitate this effort. So the county of La is actually the lead grantee, so they're kind of managing the technical effort, but all these other agencies are involved in the Regional Steering Committee and essentially we're helping to guide the technical oversight of it to create this Regional Climate Action Plan, as well as coordinating outreach and engagement.

So that we are coordinating with cities, nonprofits, business groups, everyone across the bicounty region who might have really good ideas for what investments should come out of this program and be applied for. So, as I mentioned before, the PCAP is a prerequisite for implementation funding and any GHD reduction strategies must be included in a state. So the California PCAP or the metro area PCAP to be eligible in our region. Five of the six counties have received these planning grants and as I mentioned, La and Orange County have one planning grant. Also, tribes in our region are covered by it, those types of things. But on the right the flowchart just noting is a strategy eligible for funding. So for example, in the Laoc PCAP we'll be including buildings, building energy, also transportation and waste in our PCAP. And so anyone within the Laoc region that's an eligible entity to apply, which includes municipality and a variety of other agencies, can apply under our regional PCAP.

And then the state is also doing its parallel PCAP, which we anticipate will be much broader, and build off the state Scoping plan which really includes pretty much any sector you could think of and you would be able to apply for either one of those. So one of the challenges in this process, as I mentioned, just a really fast timeline, there's a large number of climate action plans in the Laoc metro area as well as the broader region. And so what we're doing right now is looking at all the different measures and efforts that cities across the region are taking on in the transportation, building energy and waste sectors, because we have to really prioritize, given this short timeline, which sectors to focus on. And so on the transportation side this could be DMT efforts such as improving transit service, investing in transit capital, more active transportation, smarter development patterns that reduce the amount of amount people have to drive or provide them access to really good transportation options.

On the building energy side, this includes weatherization, renewable energy, other energy efficiency projects, and on the waste side this could waste aversion, those types of things that keep any waste out of going into landfills and those types of things. And then beyond that, we anticipate other folks are maybe going to want to apply for conservation grants. And so that would be where we'd want to really make sure that the state PCAP includes those types of things as well. And of course, as I mentioned before, the state PCAP is anticipated to be much more comprehensive. The thing to pay attention to here is that on the left, that diagram, you see all the different sectors that the state Scoping plan covers. And then on the right you also see that it includes things like carbon sinks, as you know, forests, wetlands, all of those things. And so ideally, the way the state's plan will provide the umbrella under which we can all operate and then our PCAP will be a little bit more focused on some of the regional priorities.

So phase two is the implementation grants. And just remember that I mentioned that the PCAP is a prerequisite for applying for these implementation grants. And these grants are going to be due on April 1 of 2024. These are going to range between 2 million and 500 million. So if you have a smaller project, you could apply for it using a \$2 million grant and then all the way up to a 500 million dollar grant. So the applications will be due on April 1. There's 4.3 billion available to states and then metro areas and tribes and territories, and then the awards are expected in July of 2024. This chart here just shows the number of toll awards they anticipate and the amount of

funding that would go through this program in each of these tiers. And this is a national program. So metro areas will be competing against each other from across the region, from across the country, as well as states themselves.

So who and what is eligible? States, municipalities, tribes and territories are all eligible to apply under this. And they can apply as individual applicants. And these individual applicants can sub award to other jurisdictions. So for example, a county government could apply for one and then decide to sub award to various cities or other jurisdictions in it. Coalitions can also get together as well and submit a big application together. And the note that does require a memorandum of agreement, which is a heavier lift and requires really advanced planning in a very condensed timeline like this. And then in terms of the types for programs, these can be new programs, brand new, that are coming out, or they can be expanded programs. So for example, if there's a program in place that's already focused on electrification, buildings or transportation, and an applicant wants to scale that up to have more benefits, they can do that.

There's a different scoring criteria in this, but it heavily focuses on GHG reduction. And then the other component is really benefiting disadvantaged communities. So historically, marginalized communities have been red, lines, suffer from air pollution, a variety of those types of things are really emphasized. And from a layer perspective, in terms of geographically how those are defined, they're using the justice 40 approach. So there's the EJ screen map and those types of things at the federal level that we'll be looking to establish an access to. In terms of the sectors, there's transportation, electric power, industrial, wastewater and sustainable materials, agricultural, and then carbon removal such as natural lands and restoration projects that are all eligible. So very wide. And when the NOFO came out last week, we noted that there's almost nothing within these sectors that is not eligible. Just note that there's a real big emphasis on GHG reduction.

So while jurisdiction can do a plan, that plan is probably going to really need to be coupled with implementation and on the ground investments, just our role. We're working with the regional steering committee of those agencies that I noted earlier to really position the whole region and also this by county region to maximize amount of funding that comes from the CPRG. And we also want to strengthen regional climate planning, collaboration and capacity. A lot of the 89 jurisdictions in La County, there's a majority that actually have climate plans, but other counties that neighbor that is not the same case. And so to the extent that this program can facilitate more climate action plans in the region. That's another benefit. And then the other thing is, the EPA has mentioned that they would like to use this process to better position regions to compete for other federal and state focused funding.

So that's kind of a high level overview of this program. Obviously, there's a lot more detail. The NOFO itself, which provides the guidance and came out last week, is about 90 pages. So there's a lot of details in there, and happy to answer any questions now. And, of course, if anyone would like to have a separate conversation that's more in detail, happy to have you reach out to us, and we would love to talk to you about that as well. So with that, I will stop and see if there's any questions.

So CBOs are not eligible entities under this. And so I think the way CBOs would really want to engage with this is help to lift up through this planning process in partnership with cities or other jurisdictions, what particular projects would be really beneficial and how they would really benefit various communities and then work to ensure that those are put into the application process.

Ryan, I got a question. So as it relates to CBOs nonprofits, if a particular municipality could use the skill set or capabilities of either of those organizations or others, is there an opportunity for them to team with a municipality or any of the other eligible categories? Yes, I believe so. I don't see anything in the NOFO that would prohibit that. So I think there would definitely be an opportunity to partner with. The reason I asked is that when we did work with the CPUC and delete the divide on broadband infrastructure issue, were able to kind of structure a model like that so that the folks on this call could actually participate. Yeah, go ahead. I'm sorry. So I would just like to know if you could come back with a definitive answer on that before people move forward. Sure. We definitely can, because the NOFO just came out last week.

There's definitely some follow up questions that we have for EPA to establish what partnerships look like. Specifically, the NOFOs really focuses more on public agencies, but it doesn't. And so it's not as clear what the nature of partnerships between, say, a public agency and a nonprofit could be. But that is a good question that we have as well, and we will seek to get answer on that. If there's no other questions, I would just encourage you all if you have specific projects you would like to lift up or additional questions. I think part of this process is we want to ensure that it is incorporating the viewpoint of CBOs on this. It is challenging to do so in just a six month planning process. Like, ideally good planning processes, engagement processes generally take longer than six months, but we're working with what we have at the EPA level, and if you have specific types of programs or investments that you are aware of or think should be made, that would be something that we would love to lift up.

The organization was founded in honor of my son, whose life was taken in 2018 by gun violence. For Long Beach, we also focus and have a hub for community violence intervention that has been recently funded by President Biden's Initiative for Communities to really focus on community violence intervention and create strategies for their cities.

Community Builder is a 30 plus year old legacy organization in South Los Angeles that provides a broad spectrum of services ranging from the Mayor's Grid Gang youth reduction program for intervention and prevention, safe passage to schools and parks for over 30,000 kids and residents. We're also in the housing development business with 62 units of permanent supportive housing at our second location. Some of you may be familiar with the work we did during the Pandemic Crssla.org Crssla.org, which is the Community Response System of South La, where we pulled together a number of stakeholders to provide mutual aid throughout the Pandemic.

And then through our Healthcare Worker program, we just launched Cure La, which is a 21st century revolutionary approach to healthcare without walls. And the reason for that is, if anybody on this call today had to go to the hospital for a non life threatening emergency, you would not be admitted in any of the 169 hospitals in La County because they're in capacity and capacity at people who did not get the care for their diabetes, heart disease, et cetera, during the COVID pandemic. So I'll stop there. We do some public policy work as well around water. So some of you may have heard of the Groundswell Movement, which is a social justice initiative, clean, safe drinking water throughout California. And of course the Independent Professionals Association help gig workers get back to work and those who are independent contractors that were impacted by AB Five.

So we oversee the La County Workforce Development Board, the County's Office of Small Business, and a whole host of other economic and workforce development levers, including high road training, partnerships, capital development with county assets, capital loan funds and the like. So we've been partaking in the Surf program since its inception as well.

Gabriel Valley. I'm excited to be part of this group, and I can't wait till we start kind of digging into and start putting together proposals on behalf of La county that can really make a difference. Thank you, Louise. Sajel, do you want to try again?

Kevin and such know that you bring, I think, to this group. So really excited about that. Thank you, everyone.

We've only been engaged with Surf for probably about less than six months when I came on earlier in the year. And we're just really excited to talk about high quality employment programs, opportunities, and then economic development for La.

We just hosted a homeownership fair where we had 1200 folks. A lot of county employees showed up, but connecting people with down payment assistance. And we also currently are a partner with the county's Youth at Work program. I think it's a great program that all of you, if you don't know about it, you guys should even be a placement site.

And what's really brought me to surface is the recognition and knowledge that as we move into a carbon neutral economy I have served on

Edison's Clean Energy Advisory Board for seven years and I recognize that 80% of the jobs that make more than \$100,000 in the renewable sector are owned and occupied by people that are not of color.

But as you can see, as we spoke about, Kevin Harbor is the chair is a very tight race, as a lot of the surf races have been, and Benny Torres dismissed it by one vote. So Kevin Harbor is our chair. The vice chairs was essentially uncontested because there were only two nominees. Andrea came in with 17, and Stella came in with 14. So Andrea will be vice chair one, vice chair eight, and Stella will be the second chair. Scarlett, if you could kind of quickly go over the bylaws update.

Yeah, so just one of the updates is that we did receive everyone's feedback in regards to what they would like to see within the bylaws. I know we did give a suggestion and gave a little bit of homework for our steering committee members to look at the Southern region coalition bylaws. I believe they're the only HRTC that has their bylaws that has worked on bylaws and adopted them and placed them on their website. We haven't been able to find bylaws for any other regions, but we did want to make this a priority for our region to be able to just smoothly progress our work forward. And so what the surf team will be doing is in the incoming days and week ahead, we will be working on taking in the feedback, actually drafting a working document with all the provisions that were recommended by the steering committee members once this draft is more fully fleshed out.

So in the incoming week, we will be emailing everyone with a working document and we will be asking again for further review and comments and feedback to just begin finalizing this document more as we move forward. So we'll have more information about that coming up in upcoming meetings, but we wanted to a congratulate Civil Economics and Economics on securing those and again, we'll have some more

information going forward. Next slide. Fiscal agent update. Well Jose, if you're on the call, if you would like to give any updates briefly, I'm sure they'd love to hear from you. Your Maria.

Hi. Everyone, this is Maria Garcia. I don't think I had an opportunity to introduce myself at your initial meeting last week to everyone who I've not had the opportunity to meet. My name is Maria Gastia. I'm a senior program officer with California Community Foundation. In partnership with my colleague Jose Maheda, we are together project managing the Surf Fiscal Agent role for the Surf Fund. And so in terms of updates, Charles mentioned that we've been able to award two out of the three research RFPs to CDL Economics and Beacon Economics. We're right now working with them to execute the contract. Our hope is to have that done the next couple of weeks. We're also continuing to execute the contract with Paykeeper, who's going to be serving as our subcontractor to work with us in issuing out the grants to all of the affinity hub leads. And again, our hope is to have that completed within the next couple of weeks so that we can begin issuing out those grants.

And then the last update that we have is around the Catalyst grant application. As you know, the state issued out the grant application to fiscal agents under an invite only solicitation.
